### OREF, PMAR and OAR Partner on Property Disclosure Task Force

The Property Disclosure Task Force met three times in 2016 to gather input for recommendations to update the existing Property Disclosure Law. A current DRAFT has been completed by the task force and OAR staff. Recommendations will go advance to the OAR Government Affairs Committee this month, January 2017. Introduction of the OAR bill is projected for the 2018 legislative session.
