121 Seller and Buyer are not required under the preceding provision (b) to reach an agreement. If (a) or (b) fail to occur within the time period identified
122 in this section, this transaction will be automatically terminated, and all Deposits will be promptly refunded to Buyer. Buyer understands that on
123 termination of this transaction, Seller will have the right to place the Property back on the market for sale at any price and terms as Seller determines,
124 at Seller's sole discretion.

125 **6.3. Buyer's Obligation Regarding Financing.** Buyer represents to and agrees with Seller as follows:

133 (c) After Buyer notifies Lender of Buyer's intent to proceed with the Loan, Buyer will complete all paperwork requested by the Lender, including
134 payment of all application, appraisal, and processing fees, to obtain the Loan.

135 (d) Buyer will not replace the Lender or loan program selected in Section 6 (Financed) without Seller's written consent, which may be withheld
136 at Seller's sole discretion.

137 (e) Following submission of Buyer's loan application, Buyer will keep Seller promptly informed of all material non-confidential developments
138 regarding Buyer's financing and the time of Closing.

139 (f) Buyer will authorize the Lender to order the appraisal of the Property before expiration of the Inspection Period, defined in Section 14
140 (Property Inspections), or Section 1 of the OREF 058 – Professional Inspection Addendum if applicable.

141 (g) Buyer authorizes Buyer's Lender to provide non-confidential information to Buyer's and Seller's Agents regarding Buyer's loan application
142 status.

143 7. **SELLER-CARRIED FINANCING:** If the Seller is financing all or a portion of the Purchase Price through a land sale contract, promissory note

161 **11. FLOOD INSURANCE:** If the Property is located in a high-risk flood zone, flood insurance may be required as a condition of a new loan. Buyer is
162 encouraged to promptly verify the need for, and availability and cost of flood insurance. An Elevation Certificate ("EC") is a document used by the
163 National Flood Insurance Program to determine the difference in elevation between a structure and the elevation to which floodwater is anticipated

175 064 – Notice of Buyer's Unconditional Disapproval to Seller, all earnest money deposits will be promptly refunded to Buyer, and this transaction will
176 be terminated.

177 **14. PROPERTY INSPECTIONS:** Buyer understands it is advisable to have complete inspections of the Property by qualified licensed professionals
178 relating to such matters as structural condition, soil condition/compaction/stability, survey, zoning, operating systems, suitability for Buyer's intended
179 purpose, and environmental issues. The following list identifies some, but not all, environmental issues found in and around many properties that may
180 affect health: asbestos, carbon monoxide, electric and magnetic fields, formaldehyde, lead and other contaminants in drinking water and well water,
181 lead-based paint, mold and mildew, radon, and leaking underground storage tanks. If Buyer has any concerns about these conditions or others, Buyer

195 Seller will not be required to modify any terms of this Agreement. Unless a written agreement has already been reached with Seller regarding
196 Buyer's requested repairs, Buyer may give Notice to Seller, using OREF 064 – Notice of Buyer's Unconditional Disapproval, at any time during
197 the Inspection Period, of Buyer's unconditional disapproval of the Property based on any inspection report, in which case all Deposits will be
198 promptly refunded and this transaction will be terminated. If Buyer fails to provide Seller with written unconditional disapproval of any inspection
199 report(s) by 5:00 p.m. of the final day of the Inspection Period, using OREF 064 – Notice of Buyer's Unconditional Disapproval, Buyer will be
200 deemed to have accepted the condition of the Property. If before expiration of the Inspection Period, written agreement is reached with Seller
201 regarding Buyer's requested repairs, the Inspection Period will automatically terminate unless the parties agree otherwise in writing.

202 (b) **Alternative Inspection Procedures.** Buyer has attached OREF 058 – Professional Inspection Addendum to this Agreement.

203 (c) **Buyer's Waiver of Inspection Contingency.** Buyer represents to Seller and all Agents and Firms that Buyer is fully satisfied with the

227 a prompt refund of all Deposits. If requested by Seller, Buyer will Deliver to Seller a copy of written reports or evaluations, if any, with the Notice of
228 Cancellation.

229 Buyer's failure to Deliver to Seller the Notice of Cancellation on or before midnight on the last day of the LBP Contingency Period will constitute
230 acceptance of the condition of the Property as it relates to the presence of lead-based paint or lead-based paint hazards, and the LBP Contingency

- 386 (d) **Closing, Closed, or Closing Date** mean when the deed or contract is recorded and funds are available to Seller.
- 387 (e) **Deliver or Delivered** means transmission of a document, either by placing it in a U.S. mailbox, taking it to the recipient's address, or placing
388 it in the custody of a delivery service ("Manual Delivery"), or by pushing "send" or "start" on a device that sends facsimiles or in an electronic
389 mail program ("Electronic Delivery").
- 390 (f) **Deposits** means the Deposit and any Additional Deposit described in Section 1 (Parties/Property Description/Price) of this Agreement.
- 391 (g) **Effective Date** means the date when this Agreement has been Signed and Delivered.
- 392 (h) **Firm** means the real estate company with which an Agent is affiliated.
- 393 (i) **Notice** means a written statement Delivered using the Notification Method described in Section 41(g) (Miscellaneous).
- 394 (j) **Notify** means delivering a Notice to the other party or their Agent.
- 395 (k) **Signed and Delivered** means the date and time the Seller and Buyer have: (i) signed a document, and (ii) Delivered it to the other party
396 or their Agent. When a document is "Signed and Delivered," the document becomes legally binding on Buyer and Seller, and neither has the
397 ability to withdraw it.
- 398 (l) **Smart Home Features** means appliances, lighting, or electronic devices that can be controlled remotely by the owner, often via a mobile

421 to their respective Agent with the same effect as if Delivered to that Buyer or Seller. On opening of this transaction with Escrow, Buyer, Seller,
422 and their respective Agents, where applicable, will provide Escrow with their preferred means of receiving Notice (for example, email or text
423 address, facsimile number, mailing or personal delivery address, or other), which will serve as the primary location for receipt of all Notices or
424 documents (the "Notification Method"). Notice will be deemed Delivered as of the earliest of:

DISPUTE RESOLUTION

430 **42. FILING OF CLAIMS:** All claims, controversies, and disputes between Seller, Buyer, Agents, and/or Firms, relating to the enforcement or
431 interpretation of this Agreement (including those for rescission) as well as those relating to the validity or scope of the Sale Agreement, and all matters
432 concerning the jurisdiction of the arbitrator(s) and/or Arbitration Service of Portland, to hear and decide questions of arbitrability (collectively, "Claims"),
433 will be exclusively resolved in accordance with the procedures in this Agreement, which will survive Closing or earlier termination of this transaction.
434 All Claims will be governed exclusively by Oregon law, and venue will be placed in the county where the Property is situated. Filing a Claim for
435 arbitration will be treated the same as filing in court for purposes of meeting any applicable statute of limitations or statute of ultimate repose, and for
436 purposes of filing a *lis pendens*. By consenting to the provisions in this Agreement, Buyer and Seller acknowledge they are giving up the constitutional
437 right to have Claims tried by a judge or jury in state or federal court, including all issues relating to the arbitrability of Claims.

- 441 (c) If the matter is exclusively between REALTORS® and is otherwise required to be resolved under the Code of Ethics & Professional
442 Standards Policies of the National Association of REALTORS®;
- 443 (d) If the matter relates to a commission or fee with an Agent or Firm, and the written listing, service or fee agreement with Buyer or Seller
444 contains a mandatory mediation and/or arbitration provision; and
- 445 (e) Filing in court for the issuance of provisional process described under the Oregon Rules of Civil Procedure; however, such filing will not
446 constitute a waiver of the duty to utilize the dispute resolution procedures described in this Agreement.

447 **44. SMALL CLAIMS BETWEEN BUYER AND SELLER:** All Claims between Buyer and Seller within the jurisdiction of the Small Claims Court of the
448 county in which the Property is located will be brought and decided there, in lieu of mediation, arbitration, or litigation in any other forum. Even though
