

REAL ESTATE TEAM DISCLOSURE

Real estate agents may form teams to represent their clients. Oregon law defines a real estate team as one or more real estate agents working together as part of a real estate brokerage, performing real estate services under a name that differs from the brokerage's name. The law allows people who are not real estate licensees to also be part of teams. Oregon law requires a member of a real estate team to deliver this Real Estate Team Disclosure (this "Team Disclosure") at first contact with a prospective party to a real property transaction, or an unrepresented party seeking representation during the course of a real property transaction. This Team Disclosure must be delivered at the time the team has sufficient contact information about a person to be able to provide this Team Disclosure to that person.
